DEFENDANT HAMPSHIRE SUPERIOR COURT'S MOTION TO DISMISS

NOW COMES the Defendant, Hampshire Superior Court, and moves this court to dismiss it as a party from this matter for the following reasons: 1. The Hampshire Superior Court is not a properly-named defendant in an action for judicial review under G.L. c. 40, § 17; 2. It is an inherent conflict of interest for the Hampshire Superior Court to be both a named defendant and the tribunal before which this matter is to be decided; and 3. The Hampshire Superior Court is not a true adverse party to this action.

Plaintiff, Timothy R. Fondakowski, has brought this action for judicial review under G.L. c. 40A, § 17 challenging the issuance of a special permit to co-defendants, Cotton Tree Service, Inc. and Dodge Maple Grove Farm, LLC. The following is a brief background recited for the purposes of this motion only: In December 2013, co-defendants Cotton Tree Service, Inc. ("Cotton Tree") and Dodge Maple Grove Farm, LLC ("Dodge") applied to the Westhampton

Planning Board for a special permit to operate a commercial saw mill. Complaint at ¶ 25. After the application was denied, Cotton Tree and Dodge sought judicial review pursuant to G.L. c. 40A, § 17¹. *Id.* at ¶ 28, *see also* Exhibit A. On April 3, 2017 the parties to that action entered an agreement for judgment. Complaint at ¶ 30 and its Exhibit 4, *see also* Exhibit A. On May 31, 2017, the Hampshire Superior Court issued a "Judgment on Agreement of the Parties Ented (sic) by the Court Pursuant to Agreement for Entry of Judgment Special Permit Decision." *See* Exhibit A and Complaint Exhibit 1. This action for judicial review under G.L. c. 40A, § 17 from the aggrieved-party Plaintiff followed.

1. The Hampshire Superior Court Must Be Dismissed from This Matter Because It Is an Improperly Named Party to a G.L. c. 40A, § 17 Action for Judicial Review.

Section seventeen of chapter 40A ("the Zoning Act") provides an aggrieved person with the right to judicial review of an act of a municipal body relevant to zoning regulations. In pertinent part, G.L. c. 40A, § 17 states:

any person aggrieved by a decision of...any *special permit granting authority* ...may appeal to...the superior court department in which the land concerned is situated...."

Relevantly, the statute reads further:

If the complaint is filed by someone other than the original applicant, appellant or petitioner, such original applicant, appellant, or petitioner and all members of the board of appeals or *special permit granting authority* shall be named as parties defendant with their addresses."

G.L. c. 40A, § 17 (emphasis added). It is noteworthy that by the statute's own definition, a Superior Court Department is not a "special permit granting authority."

"Special permit granting authority" shall include the board of selectmen, city council, board of appeals, planning board, or zoning administrators as

designated by zoning ordinance or by-law for the issuance of special permits."

G. L. c. 40A, § 1A. Clearly, the legislative intent of judicial review under G.L. c. 40A is to review decisions of municipal bodies; however, the process does not include naming as a party-defendant any entity other than those enumerated by statute, let alone a division of the judiciary. Therefore, the Court must dismiss this action against the Hampshire Superior Court for it is not a "special permit granting authority" and is an improperly named party to this action.

2. The Hampshire Superior Court Must Be Dismissed from This Matter Due to Conflict of Interest.

Even if the Court were to assume for the sake of argument that the Hampshire Superior Court were a proper defendant to this action, the Plaintiff asserts that the Hampshire Superior Court² exceeded its authority in issuing the special permit. See Complaint ¶¶ 48-49. Section seventeen of chapter 40A provides the aggrieved person with the right to a "hearing de novo and a finding of the facts by the court." Pendergast v. Bd. of App. of Barnstable, 331 Mass. 555, 558 (1954). Thus, the court proceeding is not merely limited to review of an administrative record maintained by the local zoning board. The court must:

hear all evidence pertinent to the authority of the board or special permit granting authority and determine the facts, and, upon the facts as so determined, annul such decision if found to exceed the authority of such board or special permit granting authority or make such other decree as justice and equity may require.

G.L. c. 40A, § 17. In the instant case, the underlying matter already included judicial review under G.L. c. 40A, § 17. See Exhibit A. Here, Plaintiff begs the Hampshire Superior Court to review, annul, and to vacate its own order. Complaint at p. 6. Asserting a cause of action against a named defendant that must also review its own actions is such an obvious conflict of interest that it warrants the Hampshire Superior Court to be dismissed as a party. Although a Superior

Court department can hear and review an action for judicial review under G.L. c. 40A, § 17, it need not and should not be made a party defendant to do so. Plaintiff has named the Hampshire County Superior Court as a party defendant in error, and the Hampshire Superior Court should be dismissed from this action.

3. The Hampshire Superior Court Must Be Dismissed from This Matter Because It Is Not an Adverse Party.

The Hampshire Superior Court's role in the underlying matter was purely adjudicatory. It is not a true adverse party to this action: it has no substantive interests at stake and no interest in the outcome. *See Silvia v. Duarte*, 421 Mass. 1007, n. 1 (1995); *Soja v. T.P. Sampson Co.*, 373 Mass. 630, 632 n. 2 (1977); *Lally v. Dorchester Div. of the Dist. Court Dept.*, 26 Mass. App. Ct. 724 (1988). Since the Hampshire Superior Court is not a true adverse party, its participation as a defendant is not needed to resolve this matter. Allowing the instant motion would in no way prejudice the true adversarial parties to this action, but would instead allow for the conservation of already limited Commonwealth resources.

For all of the foregoing reasons, the Plaintiff's complaint against the Hampshire Superior Court cannot stand and should be dismissed with prejudice pursuant to Mass. R. Civ. P. 12(b)(1).
